# **Old Business: Legislative Update**

**RLBSS/Formula Change:** There is a signed bill moving forward in the legislature that contains an increase in RLBSS funding to regional library systems, along with the formula change previously discussed and supported by the PLS board. Both the formula change and an increase in RLBSS funding are beneficial to Pioneerland. More information will be shared as it becomes available.

**House Omnibus Education Policy Bill (HF 1591):** This bill contains language recommended by State Library Services which would change MN Statutes, section 134,20, subd. 2, to require that the governing board of a regional library system employ a chief administrative officer who is compensated by no more than one regional library system. This is a modified version of the provision in the MDE policy bill requiring that the governing board of a regional library system employ a full-time chief administrative officer. PLS Executive/Finance Committee is opposed to any such language as limiting local autonomy and regional governing boards' ability to hire based on local needs.

### **New Business:**

**2015 Annual Report:** A request for approval to sign/submit the Annual Report to State Library Services was approved on a motion by Heimerl, seconded by Anderson.

# **Directors Report:**

RLTA: Due to the large increase in the cost of PLS's upgraded telecommunications network, which increased our share of requested RLTA dollars, we have been asked to provide specific documentation for review by State Library Services. PLS Admin has provided all documents requested and will continue to cooperate in every way possible.
