NEW BUSINESS: Pioneerland's lease agreement with Kandiyohi County for office space is up as of 12-31-2016. A. Library Projects Update:

Cosmos Library: PLS staff has met with the contractor about data and electrical wiring design. Construction is ahead of schedule and the building completion, originally scheduled for mid-November, may be sooner. Warner will not be available to install Internet connection without a minimum of 6-weeks' notice. PLS has asked the city to inform us as soon as possible if the opening date is moved up.

New London Library: The city of New London continues to explore options for a different library building. The current building is in the basement of a professional office and is not ADA compliant. New London may consider a local option sale tax to help fund construction of a new building. Most likely this would be a city offices/library combination.
